### **CONTEST RULES**

#### 1. HOW TO ENTER & ELIGIBILITY

No Purchase Necessary. Contest is open to residents British Columbia only. Entrants can enter to win a \$50 Gift Card to Bella Coola Consumers Co-operative Association.

Contest runs on October 13, 2023 from 11am to 4pm.

To be eligible, participant must fill out an entry form online or ballot form. Further, you must be a Canadian resident 18 years of age or older. Void where prohibited. Contest is not open to employees of CityWest, its affiliated companies or subsidiaries, its sales agents, its advertising and promotional agencies, and members with whom they are domiciled.

By accepting these Contest Rules, entrants agree that any and all liability related to this contest by CityWest is limited to the value of the Prize(s) as defined hereinafter.

#### 2. THE PRIZE

The awarded prize(s) will consist of:
