CONTEST RULES

1. HOW TO ENTER & ELIGIBILITY

No Purchase Necessary. Contest is open to residents British Columbia only. Entrants can enter to win a gift card.

Contest runs July 10-13.

To be eligible, participant must fill out a ballot at the event and the form online. Further, you must be a Canadian resident 18 years of age or older. Void where prohibited. *Contest is not open to employees of CityWest, its affiliated companies or subsidiaries, its sales agents, its advertising and promotional agencies, and members with whom they are domiciled.*

By accepting these Contest Rules, entrants agree that any and all liability related to this contest by CityWest is limited to the value of the Prize(s) as defined hereinafter.

2. THE PRIZE

The awarded prize(s) will consist of:

If the selected entrant cannot be reached within five (5) business days, or if the selected entrant does not meet any of the contest requirements, another entrant will be selected from the remaining eligible entries.
