

## **PRINCE RUPERT PHONE BOOK** **CONTEST RULES**

### 1. HOW TO ENTER & ELIGIBILITY

No Purchase Necessary. Contest is open to anyone. Entrants can enter to win a chance to have their photo on the cover of the phone book in Prince Rupert.

Contest runs from August 17 to 31, 2023

- a. Participants must submit a portrait style photo taken in Prince Rupert or a surrounding area to the email address [promotions@cwct.ca](mailto:promotions@cwct.ca) while the contest is active.
- b. The photo must be of 300DPI or higher to be considered in this contest.
- c. Participants must also provide details of what the photo is, where it was taken, and provide a number for us to contact.
- d. This photograph has not been sourced from the internet, and I have not engaged in any form of plagiarism.
- e. Further, you must be a Canadian resident 18 years of age or older. Void where prohibited.

By accepting these Contest Rules, entrants agree that any and all liability related to this contest by CityWest is limited to the value of the Prize(s) as defined hereinafter.

### 2. THE PRIZE

The awarded prize will consist of the winning photo submission to be the cover of the next Prince Rupert Phone Book.

Prize(s) must be accepted as awarded and with no substitutions, is/are not transferable unless set out in the Contest Rules and cannot be exchanged with CityWest for cash. CityWest reserves the right to substitute any portion of the Prize with a Prize of equivalent value if such prize becomes unavailable for any reason. The chances of winning are dependent upon the total number of eligible entries received.

### 3. THE DRAW

Members of the CityWest will select the top photos to publicize on social media for public voting. The public voting will be held through QuestionPro (anonymous online voting platform) on September 4 to 11, 2023. Winner with the most votes will be named the winner of the contest.

Selected entrant will be notified by e-mail and telephone if a number was provided. If the selected entrant cannot be reached within five (5) business days, or if the selected entrant does not meet any of the contest requirements, another entrant will be selected from the remaining eligible entries.

To win, the selected entrant must correctly answer, unaided, a mathematical skill-testing question and will be required to sign a standard release form. If the selected entrant is under the age of majority in his/her province of residence, his/her parent or legal guardian must read and accept these Contest Rules. Failure to answer the skill-testing question correctly, comply with

the Contest Rules or sign and return the release form within seven (7) days of receipt will result in disqualification and another entry will be selected until the Prize is awarded.
